

## 2020 Nebraska State Mid-Range (600 yard) Championship

### **EASTERN NEBRASKA GUN CLUB**

**August 22-23**

**Rules:** This is an NRA registered match. NRA High Power Rifle Rules will apply. Rifle weights may be checked to ensure compliance.

**Match Fee:** \$65 for both days (includes \$5.50 NRA reg. fee). Competitors must shoot both days.

**Registration:** Registration will be by Practiscore. Opening of registration will be posted on the website (nebraskafclass.com) and social media. Range will be open by 0700. Competitors must sign in at the trailer on the 600yd firing line between 0700 and 0800 on both days to receive squadding and to sign Liability Statement. **Please be at the range and signed in by 0800.** Safety briefing to start at 0815 with match starting immediately thereafter. Late arrivals may be turned away at the discretion of the Match Director. Walk-on registration will not be accepted unless approved by the Match Director.

**Eligibility:** Open to the public. Anyone who can legally possess a firearm, or juniors accompanied by a parent or guardian may compete. NRA membership is encouraged but not required. Only NRA members' scores may be considered for national records. For the purpose of 60 shot Aggregate National Records, the first three matches of each day will be submitted for national records if eligible. The NRA mid-range classification system will be used. The Match Director or Chief Range Officer reserves the right to disqualify any unsafe rifle, ammunition, or competitor.

**Equipment Allowed:** In accordance with current NRA rules. Rifles allowed are: (3.1) Service Rifle, (3.3) NRA Match Rifle, (3.4.a) F-Class Open Rifle, (3.4.b) F-Class Target Rifle. **Compensators, suppressors and muzzle brakes are prohibited** (3.16.1). **Empty chamber indicators are required** (3.21).

**Course of Fire:** All shots are slow fire prone at 600 yards. Targets are MR-1C and MR-1FC

Saturday, 22 August, 0830

- Match 1** Unlimited sighter shots, 20 shots for record, 25 minute block time.
- Match 2** 2 sighter shots, 20 shots for record, 25 minute block time.
- Match 3** 2 sighter shots, 20 shots for record, 25 minute block time.
- Match 4** The Aggregate of Matches 1 through 3.

Sunday, 23 August, 0830

- Match 5** Unlimited sighter shots, 20 shots for record, 25 minute block time.
- Match 6** 2 sighter shots, 20 shots for record, 25 minute block time.
- Match 7** 2 sighter shots, 20 shots for record, 25 minute block time.
- Match 8** The Aggregate of matches 5 through 7.
- Match 9** The Aggregate of matches 4 and 8.

**Competitors are required to perform scoring and pit duty on their assigned relay and target set up after sign-in and re-facing at match conclusion. Failure to do so will result in disqualification.**

**Awards:** All awards are based on results of match 9. Awards will be without respect to age, gender, or place of residence. First, second, and third place trophies will be awarded to the top three competitors in each of the four rifle divisions (Service rifle, Match rifle, F Open and F-TR). In addition, individual medals will be awarded to the top competitor in each rifle division in the Expert, Sharpshooter and Marksman classification. These medals will be awarded regardless of the number of entrants. Steps toward the NRA Distinguished Rifleman Award will be reported based on the Grand Aggregate (Match 9) score.

**Additional Information:**

**Location:** The range entrance is on the North side of Nebraska Highway 66 about three miles east of Louisville at the blue 12700 marker. The entrance is immediately on the West edge of the cemetery with the large pine tree.

**Inclement weather:** The conduct of the match may be altered at the Match Director's discretion in case of inclement weather.

**Range Capacity:** There are 20 target carriers and 20 firing positions on a concrete slab under a metal cover. There will be one hospital target between the F Class and sling shooters. Maximum capacity is 57 shooters with 3 man squadding and 76 shooters with 4 man squadding.

**Prize Table:** Intent is to have a meaningful prize table depending on sponsor participation. These prizes will be awarded by random drawing.

**Block Time:** The 25 minute block time includes the 3 minute preparation period and 22 minutes for the two sighters and 20 shots for record. ECIs remain in the rifles until the block time begins. Firing is authorized when block time begins. Shooters taking unlimited sighters must finish in the 25 minutes.

**Pit Safety:** All shooters travel to the pits in private vehicles and must have a seat inside. Parking is limited, so please fill the vehicles. Hats and ear and eye protection are strongly recommended in the pits.

**Rifle Zero:** Please arrive with a 600 yard zero. More than 5 misses getting on target may result in disqualification.

**Refunds:** Refunds for cancellation will not be given after 1200 hours on Friday, 21 August.

**Lodging:** There are no camping or lodging facilities on the range. The nearest hotels are located to the North in Omaha near exit 442 on I-80 and to the Northeast in Bellevue near the Cornhusker exit on US 75. Both locations are 20 to 25 minutes from the range.

**Portable toilets are available. No food or water is provided. Expect hot weather. Bring what you need. Breaks for meals and or refreshments will not be given.**
